It is expected of highly developed intelligent civilized Citizens in the Netherlands to
apply the full Constitution 2014-2016 voluntarily and legally correct for problemsolving
in daily lives.

UN-treaty Anti-war-Clause Contracts / Anti-Fire-Treaty, Space-proof

The State parties to this Convention:

Provide in contracts between the People, which guarantee an Anti-war lifestyle, on Earth and
in Space for each Individual & Organisation.

This Convention determines the methods of work of each Individual & Organisation on Earth
and in Space.

And will be conducted by the Netherlands – Worldwide – Spacewide, with the targets:

- To stop the War-makery on Earth and in Space.
- To anticipate on Fire-risks & Fires on Earth and in Space, caused by UNmemberstates
who damage Space-products of their own and those of other fellow UNmemberstates;
launched into Space by themselves or one of the fellow UNmemberstates.
- To prevent Commercial Space-companies from being turned into a War-makery
under manipulation by UNmemberstates-Criminals.
- To replace DictatorshipNL with the RepublicNetherlands.
- To make the InternationalCriminalCourt operate like a fair CriminalCourt anchored in
the UNcharter – Humanrighttreaties – Statute of Rome + other Conventions.
- To determine the legal position of the International Court of Justice, inherent to this
Convention Anti-war-Clause Contracts / Anti-Fire-treaty, Space-proof.

This Convention will be conducted by all UNmemberstates, with the targets:

- Standardization of International law = each UNmemberstate works with – preferably –
the identical Punishment-system against violations of the Constitution + National law +
UNcharter + Torturetreaty + Humanrighttreaties + Anti-Fire-treaty, Space-proof.
- The removal of all time – energy - money wasting bureaucratic legal procedures from
the current Justice-system for the punishment of Civilians & Organisations.
- To simplify the thinking – & behavioralpatterns for the Individual civilians &
Organisations in relation to punishments.

By fine-tuning the methods of work inherent to the Convention Anti-war-Clause Contracts /
Anti-Fire-treaty, Space-proof – and in case of a conflict – the conflicts will be judged upon by
the Arbitration-courtsystem, with its legally obliged procedure Problem-solving solution for
Conflict-ending. Problems will be kept small and solutions for problem-solving will be
conducted on shorter timelines. Civilians can no longer sabotage the proces of the legally
correct lifestyle anchored in the Constitution – National law – UNcharter – Torturetreaty-
Humanrighttreaties – Anti-Fire-treaty, Space-proof.

Clever persons can make a lot of money thanks to this Convention.

Article 1 Space-product: Space-risk and Earth-risk

1. Space: the Atmosphere of Earth and all sets of elements outside the Atmosphere of Earth.
2. Space-products: all touchable – visible – recognizable – workable – passive sets of elements, present in the sets of elements in the Atmosphere of Earth and outside the Atmosphere of Earth.
 - (a) Space-products can be produced by Mankind on Earth, or by Nature.
 - (b) Space-products can be inherent to UNmemberstates – Individuals – Organisations on planet Earth; or can be Standalone Nature on Earth or in Space. UNmemberstates – Individuals – Organisations can own a legally valid claim on a Space-product.
 - (c) Space-products can be free of risk to Mankind – Earth – Space; can be of minor risk to Human beings – Earth – Space; can be a significant danger to Nature – Earth – Space.
 - (d) Space-products produced by UNmemberstates – Individuals – Organisations must be produced free of risk to Mankind – Nature – Earth – Space.
 - (e) Space-products produced by UNmemberstates – Individuals – Organisations which prove not to be free of risk to Mankind – Nature – Earth – Space, must be turned into a free of risk systems, as quickly as possible.
 - (f) Space-products produced by UNmemberstates – Individuals – Organisations which can not be turned into free of risk goods & services must be disassembled by the authentic maker of these Space-products; this original Space-product producer may give a written command to a third party for the disassembly of the Space-product.
 - I. All disassembled Space-products must be recycled by optimal knowledge of business.
 - (g) All UNmemberstates – Individuals – Organisations who live & work with Space-products have the legal obligation to inform a fellow UNmemberstate – Individual – Organisation on possible Security – & Safety-risks inherent to a Space-product in functioning, from the nano-second an UNmemberstate – Individual – Organisation notice 'that there is something wrong with the way the Space-product of a fellow UNmemberstate functions on Earth and/ or in Space'.
 - I. An UNmemberstate – Individual – Organisation who fails to inform a fellow UNmemberstate – Individual – Organisation who is legally responsible for the functioning of a Space-product, about the fact that this specific Space-product is not working free of risk at the moment, is considered to be a warcriminal; and, will be punished for **not** conducting the National Constitution + UNcharter + Torturetreaty + Humanrighttreaties + Anti-war-Clause Contracts Convention / Anti-Fire-treaty, Space-proof.
 - II. The punishment for **not** informing a fellow UNmemberstate – Individual – Organisation who is the owner of a Space-product, in case of a Security & Safety-risk which must be repaired & removed by the owner of the Space-product = one year in prison, plus the obligation to conduct a payment for the Damage in favour of the UNmemberstate – Individual – Organisation who suffers due to the Security & Safesty-risk.

Condition for receiving a Damage-payment caused by a failure of a Space-product that results in the legal framework Security – & Safety-risk =: the UNmemberstate – Individual – Organisation who is entitled to receive this Damage-payment must operate legally correct himself – herself – itself, in accordance with the UNcharter + Torturetreaty + Humanrights treaties + Anti-war-Clause Contract / Anti-Fire-treaty; in connection with this specific Space-product that is at trial.

Article 2 Anti-Fire-obligation inherent to Space-products

1. Space-products wear out – are in need of maintenance & repair – fall still – need to be recycled.

Space-products can be sabotaged by manufacturers with Evil Targets, with the aim to cause

Pain & War to Mankind – Nature – Earth – Space. Fire & Demolition of Specimen of Nature & Space are the first Security – & Safety-risks that occur. The start of a Fire-risk or Fire in a Space-product must be prevented with all available tools & measures, in Space and on Planet Earth.

Example:

UNmemberstates' corrupt Politicians and their corrupt Friends sabotage the Satellite of another UNmemberstate for reasons of Sadism – Espionage – Demolition – the War-makery & War. This results in Fires in the Space-product system. These Fires in Space-products in Space, also cause Fire-risk & Fires on Earth, in the products that depend on the methods of work of the Satellite in Space. **This is a Warcrime.**

This type of Warcrime can be prevented with the Anti-war-Clause added to each Legal Contract on Earth; every Contract determines that warcriminals in Space who sabotage Space-products, will be punished.

2. Space-products which can't function to the best of their possibilities, cause Fire-risks. All UNmemberstates – Individuals – Organisations are legally obliged to handle Space-products in a way that they will not cause Fire-risks or Fires. They produce and use the manual for handling a Technology-device inherent to a Space-product, correctly.
3. Space-products which function free of risk or at a minimum of risk for Mankind – Nature – Earth – Space, can be sabotaged by UNmemberstates – Individuals – Organisations, with the aim to damage the correct functioning of the Space-product for Evil Targets.
 - a) An Evil Target in connection with the functioning of a Space-product is: to change the methods of work of the Space-products with the aim to cause Pain & War; to sabotage the Anti-war-Clause Contracts or to start the War-makery, or to be at War.
 - b) An Evil Target in connection with the functioning of a Space-product, can be conducted by each UNmemberstate – Individual – Organisation, who refuses to exercise the National Constitution – UNcharter – Torture-treaty – Humanright treaties – the Anti-war-Clause Contract / Anti-Fire-treaty.
 - c) The manufacturer of the Evil Target who causes damage to a Space-product for reasons of Sadism – Espionage – Demolition – the War-makery – Greed – all kinds of Emotions, will be punished **with** one year in prison, plus the obligation to conduct a payment for the Damage caused to the UNmemberstate – Individual – Organisation who suffers due to the Security & Safety-risk.
 - I. The manufacturer of the Evil Target that changes the methods of work of the Space-product with the aim to bring fellow UNmemberstates – Individuals – Organisations into Pain & War, will be held accountable for being this manufacturer of the Evil Target.
 - II. The UNmemberstate – which is the place of residence for the manufacturer of the Evil Target – is accountable for the criminal behavioral-pattern conducted by the manufacturer of the Evil Target. This UNmemberstate, where the manufacturer of the Evil Targets resides, is obliged to punish this Individual & Organisation.

UNmemberstates' corrupt Politicians and their corrupt Friends, can be the Big Criminal Brain behind the Pain & War caused by sabotaging the methods of work of a Space-product – and Technology-devices inherent to a Space-product –. In this **Crime-file**, other fellow UNmemberstates – Individuals – Organisations are legally obliged to conduct the National Constitution – UNcharter – Torture-treaty – Humanright treaties – the Anti-Fire-treaty... and to make sure that the President – Heads of State – Members of Parliament – Criminal Judges – other Criminals involved in sabotaging the functioning of a Space-product, on the territory of that UNmemberstate --- or on the territory of the UNmemberstate where the victim resides---, **will be punished** for sabotaging the functioning of a Space-product.

Article 3 Anti-Fire-obligations & Business-obligations for Civilians

1. **All Organisation on Planet Earth and in Space add an Anti-war-Clause to all their Contracts.**
 - a) Meaning: They make perpetrators who are guilty of sabotaging the functioning of Space-products legally accountable for all the consequences that spring from Damaging & Demolishing Space-products. And they announce this legal activity in all contracts.
 - b) **Nobody is legally obliged to be a criminal!**
There is No Time for self-pitty left on Earth.
2. Civilians in a UNmemberstate live & work with Technology. This Technology can be Satellite-stored, and can therefore burst into flames, despite the fact that the owner of the Technology - device conducts the manual correctly.
 - a) Civilians who do live & work with a Technology-device correctly, as instructed in the manual for that specific device, are legally obliged to report sparks coming from the device, to the manufacturer / sales person / sales organisation of the Technology device.
 - b) Civilians who do conduct the instructions for the Technology-device correctly and do register sparks coming from their device, but do not report this to the manufacturer / sales person / sales organisation, lose all rights for a Damage-claim. **Are they corrupt warcriminal?**
3. Civilians are legally obliged to exercise all instructions for a safe use of a Technology-device, coming from the manufacturer / sales person / sales organisation that supplied the Technology-device to them; all Anti-Fire-instructions must be put into practice immediately, in order to anticipate on a possible outbreak of a fire in the Technology-device.
4. Civilians are obliged to conduct the national laws of an UNmemberstate in case of emergency situations caused by Technology-devices.
5. In accordance with the UNcharter – Torture treaty – Humanright treaties – the Anti-war-Clause Contracts Convention / Anti-Fire-treaty, it is forbidden for Civilians & Organisations to participate in warcrimes, on Earth and in Space.
 - a) It is a warcrime to assist an UNmemberstate – Individual – Organisation with sabotaging Space-products (like Satellites); even when this type of sabotage does not cause a Fire in a Technology-device in hands of Civilians, inherent to the Space-product.
6. Civilians can conclude that an UNmemberstate – Individual – Organisation participates in the War-makery & Wars, with the aim to manufacture Evil Targets sneakily, inherent to Space-products and Technology-devices they own.

Civilians are being afraid that they are sneakily being misused to cause Pain & start Wars for the extermination of fellow Civilians, through the devices in their hands.

 - a) In this scenario the Civilian is legally obliged to publicly inform other UNmemberstates about the Fire-risk / War-risk, in their live & work, caused by the UNmemberstate they recognize as warcriminal in Space. In case the manufacturer / sales person / sales organisation refuses to operate legally correct.
 - b) Civilians turn to the Embassy of an UNmemberstate who is most likely **not** involved in the Pain-production & War-makery of an another UNmemberstate, who does misuse Technology-devices of simple Civilians / Customers for Espionage – Demolition – Blackmail – more Criminal activities. Civilians demand an ICJ-lawcase between UNmemberstates to stop the warcrimes.

Article 4 International Court of Justice & International Criminal Court

1. **ICJ**

Each UNmemberstate who is being confronted with the Pain-production & War-makery through Space-products and Technology-devices inherent to these Space-products, conducted by a fellow UNmemberstate, is legally obliged to start an ICJ-lawsuit – International Court of Justice lawcase – against the UNmemberstate who produces / damages Space-products for Pain-production & War-makery on Planet Earth and in Space.
The goal for life during this Court-trial is to stop all types of crime, inherent to Space-products.
2. **ICC**

While writing this Anti-war-Clause for Contracts Convention, the InternationalCriminalCourt -

personnel is a Criminal gang on its own merits; and with the support of Evil UN-rulers.

In current state the ICC is not open for the Civilians – Organisation on Earth, who need to legally defend themselves against Space-product-Crime conducted by UNmemberstates who do not guarantee Acces to Court + excecutable Court-verdicts + Sound Governance + Trustworthy & profesionally working Parliament + legally correct operating Police & Defence systems.

1. Firstly, DésiréeElisabethStokkel must clean up the 100% corruption between Dictatorship Kingdom the Netherlands and ICC-personnel.
2. Secondly, DésiréeElisabethStokkel must clean up the EuropeanUnion & UnitedNations – politicians who misuse the ICC-corruption as a murder-weapon in their private life and at work.
3. During her life , DésiréeElisabethStokkel will found the Space-Earth-Justice-system for Commercial businesses.
4. Once the Netherlands is for all Individuals – Organisations on Earth and in Space a RepublicNetherlands, the People on Earth will be better protected against Evil-manufacturers who have already started a Space-war 2018.
 - a) This means: UNmemberstates already try to sabotage eachothers Satelites in Space, ignoring the Fire-risks & Fires this will cause on Earth.
5. From the day the InternationalCriminalCourt operates like a fair court of law, in favour of all Civilians on Earth, each Individual – Organisation will be able to defend itself against Evil-manufacturers in Design: UNmemberstate.
Planet Earth is lost, when ICC is not turned into a fair InternationalCriminalCourt, on a very short timeline.

Private note from the Anti-Fire-treaty, Space-proof, Designer DésiréeElisabethStokkel:
