MEMO – HEQ - ICT

SpaceX-team

I write this MEMO for the SpaceX-team, from my role as Head EQ-unit Mars-expedition.

Current legal situation inside the full SpaceX-system

- SpaceX neither demands that the InternationalCriminalCourt of Nato prove that they operate legally correct.
- SpaceX launches statelites – spacestations – human beings into Space.
- SpaceX is being pulled into legal traps, at the moment:
 - ➔ SpaceX team is being misled by Evil ICC-UN-lobby related to lawcases started against Presidents / Embassadors / Persons with International Courts of law.
 - ➔ Evil rulers want the SpaceX team to be guilty of participating in warcrimes, without SpaceX asking nasty questions about wars. Evil rulers want the SpaceX team to be guilty of warcrimes, so these Evil persons can use SpaceX for the starts of a space-war. Without being punished for doing so, of course.
- **SpaceX owns the legal obligation to have itself not being misused for war-makery.**
 - ➔ SpaceX can protect itself – realitively easy – against participating in warcrimes, by working with the ICclawcaseNL + ICclawcase against Trump – Obama – Clinton – UNSG Guterres – Presidents + other Persons.

SpaceX must operate legally correct:

- ➔ Recognize Désirée Elisabeth Stokkel as InterimPrimeMinister for NL – USA – RU – JP – NK – IR & UNSG.
- ➔ Refer to the courtcase-file ICclawcaseNL in each Business-contract SpaceX creates & signatures, with UN-memberstates – Organisations – Persons. As long as a President / Embassador / Persons stays in her of her powerfull labourcontract, all SpaceX Business-contracts are produced in ICC-UN-warzone. This makes SpaceX a participant in the war-makery. A nasty clever person can make SpaceX even go bankrupt, by blackmail – complex courtcases anchored in the Uncharter & Torture-treaty.
- ➔ Each SpaceX-Business contract must provide in a clause:
 - SpaceX implements & conducts in each contract: the UNcharter + Torture treaty + Humanrights treaties + new Humanright Police treaty + Arbitration-court treaty + EU-future-proof-treaty + newly to arrive treaties.
 - A SpaceX-contract expires from the moment it is clear that parties to the contract have entrapped SpaceX for participating in war-makery and other products of violation of International law & corruption.
 - SpaceX will start a damage-claim with the UN-memberstate / Organisation / Individual Person, who refuses to operate legally correct and tries to turn SpaceX into a warcriminal & corrupt organisation.
- SpaceX will be forced by the Whitehouse President DonaldTrump to be coöperative

with the construction of the USA-Spaceforce -Army, in Space.
This is a warcrime on behalf of the Whitehouse, in current legal settings.

SpaceX must demand with the Whitehouse that there will be new elections for President, publicly.

- There is an ICCLawcaseNL started against President Donald Trump for the legal fact that he supports the realization of Dictatorship Netherlands. + he hides for the people the legal fact that there is an ICCLawcase started against persons working for Nato.
